Pastor's Report 2021

Friends in Christ,

Thanks be to God for our first full year of walking together as partners in the gospel of Jesus Christ! I had just begun my ministry with all of you last January when it came time for the Annual Meeting, so this is my first written Annual Report for all of you. But, my goodness: where to start?! Maybe the Bible would be a good place...

To quote the Apostle Paul (in Philippians, my favorite of his letters, as you have probably heard me say more than once): "I thank my God every time I remember you, constantly praying with joy in very one of my prayers for all of you, because of your sharing in the gospel from the first day until now" (Phil. 1:3-5). Like Paul, I give great thanks for all of you—and for the trust you have placed in me. I don't take that privilege lightly; I am humbled by that trust. It is truly an honor to be here.

We can make a pretty strong assumption from Paul's letter to the Philippians that the congregation that Paul once helped to get up and running there in Philippi had a pretty special place in Paul's heart. In just a couple more verses, Paul will give us some more great phrases that are indicative of their unique partnership in the gospel as he mentions how they "hold him in their hearts" and how they "share in God's grace" with him. It's clear in this hopeful epistle that Paul's rather unpleasant "present circumstances" (he writes this letter from a prison cell) take a back seat to the joy he has in his heart because of this encouraging, supportive, guiding and mutually-emboldening relationship he has with the Philippian faithful. It makes me think of the still-relatively-new relationship you and I have with one another here.

Even though I still have moments where I find myself a bit overwhelmed by the sheer size and scope of this parish (thank you for being patient as I try to learn your names!), I continue to be in awe at the mystery of how God called us together and set us on one another's path for a life together as baptized "saints in Christ Jesus" (Paul again) here in this particular place at this particular time. It's truly remarkable, when you think about it (God calling us together), especially since our partnership in the Gospel began during the height of the COVID-19 pandemic (you had just begun worshipping back in the sanctuary the week I started, and masks were very commonplace around here).

I can still remember Sherie Heine (from our Western North Dakota Synod Office) calling me some time after I had submitted my "mobility" paperwork (August, 2020) and giving me an update from a meeting they had just had, which had included discussing congregational pastoral vacancies. "We think First, Mandan, would be a good fit for your gifts!" she excitedly said to me. And this was my less-thanenthusiastic response: "What? Are you serious? That congregation is WAY too big....I'm more suited for smaller congregations." "Well, pray about it," she then said. "Uh, o.k.," I said, fairly convinced that God agreed with my self-assessment. Leave a congregation during a pandemic? And interview at a congregation four times the size of the one you are currently serving? Are you crazy?

Well, apparently, God has a great sense of humor, because here I am. And here we are—partners in this privileged work of being God's people as now we lean forward in hopeful expectation into our second year together, sharing in God's grace and pondering with gratitude at this Annual Meeting today all that has happened this past year and where God may be leading us in mission, evangelism and outreach to one another and to our neighbors in the next 12 months. As we ponder, may the beautiful invitation that we have heard time and time again this past year, during each of the many baptisms we have had, lead us and guide us to continue be faithful followers of the crucified and risen reason for this and all seasons under heaven. He—Jesus—originally spoke these words after all: Let your lights so shine before others that they may see your good works and glorify your father in heaven.

May the Light that is Jesus continue to shine brightly in all that we say and do, and may our lights continue to burn brightly as we seek to bring hope and joy to all in Christ's name. I close by again quoting Paul, who gently reminds us that everything in our life together as God's people is to be centered in Jesus Christ:

"And this is my prayer, that your love may overflow more and more with knowledge and full insight to help you determine what is best, so that in the day of Christ you may be pure and blameless, having produced the harvest of righteousness that comes through Jesus Christ for the glory and praise of God" (Philippians 1:9-11).

Thank you all for the privilege of serving you as your pastor. May our love for each other, for Jesus, and for the world, continue to overflow as we journey together into another new year, "sharing in God's grace" in all that we say and do.

However, normalization was returned when the Fourth of July parade had a float entry from First Lutheran with a theme supporting healthcare and emergency workers. Music was provided by the local talent of Kyra Schulz and Allison Bard. We also want to thank Jakes Auto Glass for allowing us to use their building to prepare the float.

This fall we resumed our LAF (Lunch at First Lutheran) program with continued support from individuals and corporations making it again a great outreach program. It is a lunch at noon for high school students. This program will face some challenges in coming years because of the change in location of the high school. We look forward to that challenge and to find innovative ways to continue the program, making it even better.

The Truck and Treat Halloween event was a success. There were 24 car trunks giving out candy. Over 650 individuals sought warmth and a lunch of hot dogs and chips served in the dining hall.

First Lutheran outreach also included a successful food basket and Christmas tree gift giving for those in need. Volunteers continue to supply the outdoor pantries with food for individuals and families.

The church council decided not to continue with the Lutefisk supper. Attendance and ultimately revenue was shrinking; volunteer numbers also decreased. These factors contributed to retiring the event.

Property Management Team Report 2021

2021 was a busy year for the Property Management team. This would be Brian's first full year as our Custodian, and he had a lot of work to do.

This past year we tackled some "problem" areas outside of the church. First thing we did was to plant a series of bushes on the hillside on the southeast corner of the parking lot. That area is very steep and is almost impossible to mow. And as you could imagine, almost as hard to hold water. So, to remedy the problem, we decided to plant the hillside with matching bushes to eliminate the need to water and mow grass on a very steep hill. We also had to replace much of the underground sprinkler system at the church. We had noticed a water leak and we knew we had issues with the valves, so the entire system was replaced, and the "unsightly" valves were removed from the front of the church and replaced with "in ground" valves.

Secondly, we had some issues with our front sidewalks sinking and our west side apron for the parking lot was deteriorating. So, we had experts from the city of Mandan come out and help us figure out how to correct the problem. Hence, we had the sidewalks lifted by Poly Pro and had the apron and adjacent curbing replaced and new concrete poured. Brian also undertook the job of hand sealing many of the other cracks in the sidewalk.

Next, we had a parishioner notice that one of the exterior staircases was broken. We contacted a contractor and had the staircase re-welded and repaired. Brian is also taking some time out of his busy schedule to sand and repaint the exterior railings at the church. This will not be an overnight project and will be lasting into the next year or more to get all the rails and staircases repainted.

Brian also restriped most of the parking lot. I believe the upper section will be completed this year (2021). Brian also got the new "memorial" bench completed on the south entrance of the building. If you haven't noticed, we now have some additional crosses that have been installed in the garden area on the south side of the church. These crosses were built and installed by Kyler Reile as part of his Eagle Scout requirements. Brian also took the time to "freshen up" the mulch and do the weeding in the garden area.

Brian and some parishioners also did a great job with the spring cleanup. The exterior of the church is really getting cleaned up nicely and you should continue to see improvements as we move forward with Brian as our Custodian.

This past year we also had our first issue with the new boiler system. It was repaired and should no longer be a problem moving forward. The Emergency Lighting as well as the signage was also replaced in the church.

Lastly is the issue of the carpet in the office areas and the meeting rooms. It has been requested by some parishioners that these carpets be changed. We have gathered bids and have a good start on ear-marked money that has been given to this project. The remaining funds has been included in this year's budget and hopefully this project can be carried out this calendar year.

The Committee began meeting in May and continued meeting until August. We met with former First Lutheran member and now Deacon Janie Hague from Church of the Cross. She was able to give us the many and varied roles Deacons can serve in a church. We were also made aware of an individual who is studying to become a Deacon and interested in serving our church. We met with Angie Kutzer on July 19th who is nearing completion of her studies to become a Deacon. Our decision with regard to staffing needs at First Lutheran was reviewed by Bishop Schweitzer and we gave careful consideration of Pastor Phil's wishes on the decisions we were making.

The Committee voted unanimously on Aug. 15th to recommend to the Church Council to hire Angie Kutzer to the Pastoral Staff. She began her service to our church on Oct. 1st.

The Worship Committee continued to meet with Pastor Phil and Angie regarding worship services moving forward. We gave our support to looking at Contemporary worship services as well as returning to Wednesday night services. We also gave our support to Angie to organize the first Dinner Church which was held on Dec. 15th. It was a great success, and we support her plan for Dinner Church in the future.

We are encouraging the idea of forming Worship Teams from the congregation for both the 9:30 and Wednesday night services. The teams would serve as advisors in terms of the style of the service as well as the music.

Youth and Parish Education Report 2021

2021 saw some return to normal for the youth of our congregation. We were able to welcome our Sunday School youth back into the Church on Sunday mornings. Our Youth Education Coordinator, Kama Hoovestal, has worked hard to make sure that things run smoothly with all students being present on Sunday mornings as we have not yet been able to restart Wednesday School. We will be starting Wednesday School again in February 2022.

We were able to welcome Camp of the Cross to do a one day camp for Bible School this year. We had 58 youth attend that event.

The Confirmation Service for the 2020 students was postponed due to COVID, but we were able to hold the Confirmation Service for those students on April 25th. We split the students into 2 groups and held separate services, which allowed all the students to invite as many guests as possible; we were still on COVID capacity restrictions at that time. It was a joy to have Pastor Phil Confirm his first group of students at First Lutheran. The Confirmation Service for the 2021 students was held on October 31st with no COVID restrictions.

The National Youth Gathering in Minneapolis that was scheduled to happen in the summer of 2021 and be attended by our Mission Trip youth was also cancelled by COVID. We were very happy to be able to plan a Mission Trip for those students as they had worked hard to raise funds and were looking forward to service and fun. The youth spent time in Minneapolis at Feed My Starving Children, a couple of days in Wisconsin Dells, and a day at Habitat for Humanity. President's Report

The last year has been anything but normal for all of us at Missouri Slope. Healthcare is a busy industry even before you add a major building project and a global pandemic. Thankfully, we have a strong group of employees, leadership team members, and board of directors who are dedicated to the organization and will do what it takes to assure the mission of Missouri Slope continues in our community. We have been blessed by the various federal relief dollars which are necessary to pay for the additional costs we have seen with labor, supplies, and everything else required to provide high quality care to our residents and tenants.

Our fiscal year ended with many new milestones in terms of revenues, expenses, occupancy, and number of employees. Our occupancy dropped dramatically as the pandemic took hold and we did all we could to respond. The Skilled Nursing Facility on Hillview Avenue reported a year end occupancy of 66% and the Assisted Living Facility reported 85%. A portion of our building was reserved for COVID+ individuals who required special isolation protocols. I am incredibly thankful for and amazed by our team members who have bonded together to find

a way to overcome challenges. Our balance sheet grew dramatically the past year due to the new Washington Campus as an asset, and the corresponding debt to finance the project. Revenues and expenses totaled \$28,073,798 and \$28,675,896. Total employees at the end of the fiscal year were 426.

Our annual corporate meeting was well attended by all our member church delegates. We are thankful to be a social ministry of our nine local ELCA churches: Faith, First Lutheran of Bismarck, First Lutheran of Mandan, Good Shepherd, House of Prayer, Lord of Life, Lutheran Church of the Cross, Trinity, and Sunne. Our ministry and mission has thrived because of the support of our members the past 59 years and we are looking forward to the growth and opportunities being added with our new campus. The current projects and plans in motion will assure Missouri Slope will meet the needs of our community for the next 59 years!

Great challenges exist and will continue for all of us as we hope for the end of the pandemic. Every day, we pray for people with the hearts and minds of caregivers to join us in our mission and service to the community. Missouri Slope is a major employer and economic driver for our region. We continue having great opportunities for people to join our team as we complete our transition to the new Washington Campus and beyond. 2021 FIRST LUTHERAN CHURCH OF MANDAN MISSION ENDOWMENT COMMITTEE ANNUAL REPORT

The Mission Endowment Committee worked to continue efforts to generate awareness of the First Lutheran Mission Endowment Fund and increase contributions to the fund, whose purpose is to "enhance the work of the Church by establishing new ministries and stewardship opportunities".

Accomplishments of the committee this year included:

- Recognition Society. The Bridge Builder program recognized anyone who contributed a total of \$1,000 to the
 Mission Endowment Fund and added them to the "Bridge Builders Contributors" list. A plaque was made in their
 name and added to the display that is located in the atrium of the church. The "Recognition Society" honors
 generous members and friends who have included the church in their estate planning through three levels of
 giving:
 - o Torch Bearers (\$1 \$999)
 - Bridge Builders (\$1,000 \$5,000)
 - Shepherd Beacons (\$5,001 or more)

Outreach:

- The Committee was consistent in having information about the Mission Endowment Fund in the monthly newsletter and weekly bulletins throughout the year providing education, tax benefits and the importance of the fund's mission.
- The Committee established two First Lutheran Church of Mandan Mission Endowment Fund Scholarships to be awarded in 2022 to area youth for seminary or college expenses.
- **Fund Balances:** The current market conditions have increased the values in the two investments funds as of December 31, 2021. The Committee will continue to monitor performance on a quarterly basis.
