ELIGIBILITY:

Open to North Dakota high school seniors who demonstrate community and/or school involvement. The applicant must be planning to attend college full-time (12 credits or more).

INSTRUCTIONS:

1. The deadline for the 2026 scholarship application: March 31, 2026. Applications received after March 31, 2026 will not be considered for the current scholarship year.
2. Only complete applications will be considered. Do NOT leave any items blank.
3. Attach a current copy of your high school transcript and/or GED.

Consideration for the First Lutheran Church Endowment Fund Scholarship is based on a point system including participation in extra-curricular activities, school organizations and your local community as well as a brief essay. Preference will be given if applicant and/or parent/guardian is a member of First Lutheran Church. Preference will be given to those planning to attend a North Dakota college/university/vocational-technical school. Further preference will be given to those pursuing a degree related to religion or seminary school.
